RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between **GGC Tactical Debt Holdings, LLC**, a Delaware limited liability company, with its principal office at One Embarcadero Center, 39th Floor, San Francisco, California 94111 ("**Grantee**"), and **Altama Delta Corporation**, a Georgia corporation, with its principal office at 5968 Commerce Boulevard, Morristown, Tennessee 37814-1051 ("**Grantor**"), dated November 19, 2012 (the "**Trademark Security Agreement**"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantor (collectively, the "**Trademarks**"), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith;

WHEREAS, Grantor and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain 12% Secured Promissory Note dated October 5, 2012 and issued by Grantor and its affiliates;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 24, 2012, at Reel 4905, Frame 0831; and

WHEREAS, Grantor has requested that Grantee release its security interests in the Trademarks, and Grantee has agreed to release such security interests in exchange for payment of a release price acceptable to Grantee.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Grantee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

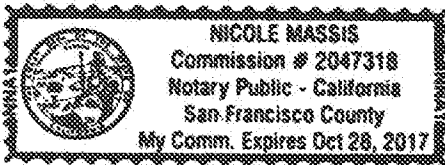
