ASSIGNMENT OF SERVICE MARK

WHEREAS, Copper River Country Club Limited, a California limited partnership composed of William R. Tatham, Sr., Ellen Earline Tatham, William R. Tatham, Jr., Michael F. Tatham, and Dana Renee Antognoli, all United States citizens, ("Assignor") adopted and used the following service marks (the "Marks"), and applied to the U.S. Patent and Trademark Office for registration thereof:


- "COPPER RIVER" for use on or in connection with, among other things, (i) recreational and club activities including golf, tennis, fitness, and food services, banquets, (ii) retail sales, and (iii) goods and services relating thereto (S/N 76591407); and
- "COPPER RIVER RANCH" for use on or in connection with, among other things, (i) development and sales of residential and commercial real estate, and (ii) goods and services relating thereto (S/N 76591408);

WHEREAS, on good and valuable consideration, the receipt and sufficiency of which was acknowledged, and effective January 1, 2005, Assignor caused to be assigned over to Copper River Food Services, a California corporation, the entire right, title, and interest in and to the Marks, including all registrations and applications thereof in the U.S. Patent and Trademark Office, the Trademark Offices of the States and Territories of the United States of America, and the Trademark Offices of other nations throughout the world, and all rights therein provided by international treaties or conventions, all divisional, extensions, or renewals of any of the foregoing, all of the goodwill of the business connected with the use of and symbolized by the foregoing, and all corresponding rights throughout the world; and

WHEREAS, on March 1, 2005, Copper River Food Services, a California corporation amended its Articles of Incorporation to change its name to Copper River Country Club, a California Corporation ("Assignee").

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor confirms that it has assigned unto Assignee all of Assignor's right, title, and interest in and to the Marks, together with the goodwill of the business connected with the use of and symbolized thereby.
