NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns and sells to Assignee all rights, title, and interest as Assignor may possess in and to the Trademarks, and the registration thereof, free and clear of any lien or encumbrance whatsoever, together with the goodwill symbolized by said Trademarks, all income, royalties, damages and payments now or hereafter due or payable with respect to the Trademarks, the right to register the Trademarks, and the right to renew or transfer any registration of the Trademarks.
