## PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT

This Patent, Trademark and Copyright Security Agreement (the "Agreement"), dated as of October 30, 2014 is entered into by and between JOHN RICH & SONS INVESTMENT HOLDING COMPANY, a Delaware corporation (the "Pledgor"), and MANUFACTURERS AND TRADERS TRUST COMPANY (the "Lender").

WHEREAS, Woolrich, Inc. ("Woolrich") and the Lender are parties to that certain Financing and Security Agreement dated as of April 18, 2013 (the "Original Woolrich Loan Agreement"), as amended by that certain First Amendment to Financing and Security Agreement dated April 22, 2014 by and among Woolrich and the Lender (the "First Woolrich Amendment") and collectively with the Original Loan Agreement, the "Woolrich Loan Agreement";

WHEREAS, the Pledgor executed and delivered to the Lender that certain Continuing Guaranty dated as of April 18, 2013 (as amended, modified, supplemented or restated from time to time, the "JR&S Guaranty (Woolrich)"), pursuant to which the Pledgor absolutely and unconditionally guaranteed the obligations owing by Woolrich to the Lender under the Woolrich Loan Agreement. The Woolrich Loan Agreement, JR&S Guaranty (Woolrich) and the other documents executed in connection therewith, as each may have been amended or modified from time to time through the date hereof, are collectively referred to herein as the "Woolrich Loan Documents";

WHEREAS, the Lender and Woolcan, Inc. ("Woolcan" and together with Woolrich and the Pledgor, the "Obligors") are parties to that certain Line of Credit By Way of Current Account Overdraft Agreement on July 31, 2012 (the "Original Woolcan Loan Agreement"), as amended and restated pursuant to that certain Line of Credit By Way Of Current Account Overdraft Agreement – Amended and Restated dated September 27, 2012 (the "A&R Woolcan Loan Agreement") and collectively with the Original Woolcan Loan Agreement, the "Woolcan Loan Agreement" and collectively with the Woolrich Loan Agreement, the "Loan Agreements"), pursuant to which the Lender made available to Woolcan a line of credit in the maximum principal amount of CDN \$1,400,000;

WHEREAS, the Pledgor executed and delivered to the Lender that certain Continuing Guarantee dated as of July 31, 2012 (as amended, modified, supplemented or restated from time to time, the "JR&S Guarantee (Woolcan)") and collectively with the JR&S Guaranty (Woolrich), the "Guarantees"), pursuant to which the Pledgor absolutely and unconditionally guaranteed the obligations owing by Woolcan to the Lender under the Woolcan Loan Agreement. The Woolcan Loan Agreement, the JR&S Guarantee (Woolcan) and the other documents executed in connection therewith, as each may have been amended or modified from time to time through the date hereof, are collectively referred to herein as the "Woolcan Loan Documents". The Woolcan Loan Documents and the Woolrich Loan Documents are collectively referred to herein as the "Loan Documents".

WHEREAS, a Default and Event of Default has occurred and is continuing under the Woolrich Loan Agreement because Woolrich failed to maintain a Debt Service Coverage Ratio

for the Fiscal Quarter ending on June 30, 2014 of not less than 1.25 to 1.0, as required pursuant to Section 6.1.15 of the Woolrich Loan Agreement (the "Specified Event of Default");

WHEREAS, the Obligors have requested, and the Lender has agreed, to temporarily forbear from exercising rights and remedies as a result of the occurrence of the Specified Event of Default, subject to the terms and conditions of that certain Forbearance and Second Amendment Agreement of even date herewith by and among the Obligors and the Lender (the "Forbearance Agreement"). In connection with the Forbearance Agreement, the Pledgor has agreed, among other things, to grant a security interest to the Lender in certain patents, trademarks and copyrights and other property as security for such loans and other obligations as more fully described herein.

NOW, THEREFORE, intending to be legally bound hereby, the parties hereto agree as follows:

1. Defined Terms.

(a) Except as otherwise expressly provided herein, (i) capitalized terms used in this Agreement shall have the respective meanings assigned to them in the Woolrich Loan Agreement and (ii) the rules of construction set forth in Section 1.3 [Interpretive Provisions] of the Woolrich Loan Agreement shall apply to this Agreement. Where applicable and except as otherwise expressly provided herein, terms used herein (whether or not capitalized) shall have the respective meanings assigned to them in the Uniform Commercial Code as enacted in Pennsylvania as amended from time to time (the "Code").

(b) "Patents, Trademarks and Copyrights" shall mean and include all of Pledgor's present and future right, title and interest in and to the following: all trade names, patent applications, patents, trademark applications, trademarks and copyrights, whether now owned or hereafter acquired by Pledgor, including, without limitation, those listed on Schedule A hereto, including all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, and the goodwill of the business to which any of the patents, trademarks and copyrights relate.

(c) "Obligations" shall mean and include the following: all now existing and hereafter arising Obligations of the Pledgor to the Lender under the Guarantees or any of the other Loan Documents, including all obligations, liabilities, and indebtedness, whether for principal, interest, fees, expenses or otherwise, of the Pledgor to the Lender, now existing or hereafter incurred under the Guarantees or any of the other Loan Documents as any of the same or any one or more of them may from time to time be amended, restated, modified, or supplemented, together with any and all extensions, renewals, refinancings, and refundings thereof in whole or in part.

2. To secure the full payment and performance of the Obligations, Pledgor hereby grants, and conveys a security interest to Lender in the entire right, title and interest of Pledgor in and to all of its Patents, Trademarks and Copyrights.

3. Pledgor jointly and severally covenants and warrants that:

(a) the Patents, Trademarks and Copyrights are subsisting and have not been adjudged invalid or unenforceable, in whole or in part;

(b) to the best of Pledgor's knowledge, each of the Patents, Trademarks and Copyrights is valid and enforceable;

(c) Pledgor is, or as provided in Section 3.k of the Forbearance Agreement will be, the sole and exclusive owner of the entire and unencumbered right, title and interest in and to each of the Patents, Trademarks and Copyrights, free and clear of any liens, charges and encumbrances, including without limitation pledges, assignments, licenses, shop rights and covenants by Pledgor not to sue third persons;

(d) Pledgor has the corporate power and authority to enter into this Agreement and perform its terms;

(e) no claim has been made to Pledgor or, to the knowledge of Pledgor, any other person that the use of any of the Patents, Trademarks and Copyrights does or may violate the rights of any third party;

(f) Pledgor has used, and will continue to use for the duration of this Agreement, consistent standards of quality in its manufacture of products sold under the Patents, Trademarks and Copyrights;

(g) Pledgor has used, and will continue to use for the duration of this Agreement, proper statutory notice in connection with its use of the Patents, Trademarks and Copyrights, except for those Patents, Trademarks and Copyrights that are hereafter allowed to lapse in accordance with Paragraph 10 hereof;

(h) Pledgor will not change its state of incorporation, formation or organization, as applicable without providing thirty (30) days' prior written notice the Lender;

(i) Pledgor will not change its name without providing thirty (30) days' prior written notice to the Lender; and

(j) Pledgor shall preserve its corporate existence and except as permitted by the Guarantees, Loan Agreements or other Loan Documents, shall not (i) in one, or a series of related transactions, merge into or consolidate with any other entity, the survivor of which is not Pledgor, or (ii) sell all or substantially all of its assets.

4. Pledgor agrees that, until all of the Obligations shall have been indefeasibly satisfied in full, it will not enter into any agreement (for example, a license agreement) which is inconsistent with Pledgor's obligations under this Agreement, without Lender's prior written consent which shall not be unreasonably withheld except Pledgor may license intellectual property in the ordinary course of business without the Lender's consent to licensees to facilitate the licensees' marketing, distribution, sale, manufacture and use of products bearing or using a Patent, Trademark or Copyright.

5. If, before the Obligations shall have been indefeasibly satisfied in full, Pledgor shall own any new trademarks or any new copyrightable or patentable inventions, or any patent application or patent for any reissue, division, continuation, renewal, extension, or continuation in part of any Patent, Trademark or Copyright or any improvement on any Patent, Trademark or Copyright, the provisions of this Agreement shall automatically apply thereto and Pledgor shall give to Lender prompt notice thereof in writing. Pledgor and Lender agree to modify this Agreement by amending Schedule A to include any future patents, patent applications, trademark applications, trademarks, copyrights or copyright applications and the provisions of this Agreement shall apply thereto.

6. Lender shall have, in addition to all other rights and remedies given it by this Agreement and those rights and remedies set forth in the Guarantees, the Forbearance Agreement and the other Loan Documents, those allowed by applicable Laws and the rights and remedies of a secured party under the Uniform Commercial Code as enacted in any jurisdiction in which the Patents, Trademarks and Copyrights may be located and, without limiting the generality of the foregoing, if an Event of Default (other than the Specified Event of Default) or Forbearance Event of Default has occurred and is continuing under the Guarantees, the Forbearance Agreement, the Loan Agreements or any of the other Loan Documents, Lender may immediately, without demand of performance and without other notice (except as set forth below) or demand whatsoever to Pledgor, all of which are hereby expressly waived, and without advertisement, sell at public or private sale or otherwise realize upon, in a city that the Lender shall designate by notice to the Pledgor, the whole or from time to time any part of the Patents, Trademarks and Copyrights, or any interest which Pledgor may have therein and, after deducting from the proceeds of sale or other disposition of the Patents, Trademarks and Copyrights all expenses (including fees and expenses for brokers and attorneys), shall apply the remainder of such proceeds toward the payment of the Obligations as the Lender, in its sole discretion, shall determine. Any remainder of the proceeds after payment in full of the Obligations shall be paid over to Pledgor. Notice of any sale or other disposition of the Patents, Trademarks and Copyrights shall be given to Pledgor at least ten (10) days before the time of any intended public or private sale or other disposition of the Patents, Trademarks and Copyrights is to be made, which Pledgor hereby agrees shall be reasonable notice of such sale or other disposition. At any such sale or other disposition, Lender may, to the extent permissible under applicable Laws, purchase the whole or any part of the Patents, Trademarks and Copyrights sold, free from any right of redemption on the part of Pledgor, which right is hereby waived and released.

7. If any Event of Default (other than the Specified Event of Default) or Forbearance Event of Default shall have occurred and be continuing under the Guarantees, the Forbearance



Agreement, the Loan Agreements or any of the other Loan Documents, Pledgor hereby authorizes and empowers Lender to make, constitute and appoint any officer or agent of Lender, as Lender may select in its exclusive discretion, as Pledgor's true and lawful attorney-in-fact, with the power to endorse Pledgor's name on all applications, documents, papers and instruments necessary for Lender to use the Patents, Trademarks and Copyrights, or to grant or issue, on commercially reasonable terms, any exclusive or nonexclusive license under the Patents, Trademarks and Copyrights to any third person, or necessary for Lender to assign, pledge, convey or otherwise transfer title in or dispose, on commercially reasonable terms, of the Patents, Trademarks and Copyrights to any third Person. Pledgor hereby ratifies all that such attorney shall lawfully do or cause to be done by virtue hereof. This power of attorney, being coupled with an interest, shall be irrevocable for the life of this Agreement.

8. At such time as the Obligations shall have been indefeasibly satisfied in full, this Agreement shall terminate and Lender shall execute and deliver to Pledgor all deeds, assignments and other instruments as may be necessary or proper to re-vest in Pledgor full title to the Patents, Trademarks and Copyrights, subject to any disposition thereof which may have been made by Lender pursuant hereto.

9. Any and all fees, costs and expenses, of whatever kind or nature, including reasonable attorneys' fees and expenses incurred by Lender in connection with the preparation of this Agreement and all other documents relating hereto, the filing or recording of any documents (including all taxes in connection therewith) in public offices, the payment or discharge of any taxes, counsel fees, maintenance fees, encumbrances, the protection, maintenance or preservation of the Patents, Trademarks and Copyrights, or the defense or prosecution of any actions or proceedings arising out of or related to the Patents, Trademarks and Copyrights, shall be borne and paid by Pledgor within fifteen (15) days of demand by Lender, and if not paid within such time, shall be added to the Obligations and shall bear interest at the highest rate prescribed in the Woolrich Loan Agreement.

10. Pledgor shall not abandon any Patent, Trademark or Copyright without the consent of Lender, which shall not be unreasonably withheld.

11. Pledgor shall have the right, with the consent of Lender, which shall not be unreasonably withheld, to bring suit, action or other proceeding in its own name, and to join Lender, if necessary, as a party to such suit so long as Lender is satisfied that such joinder will not subject it to any risk of liability, to enforce the Patents, Trademarks and Copyrights and any licenses thereunder. Pledgor shall promptly, upon demand, reimburse and indemnify Lender for all damages, costs and expenses, including reasonable legal fees, incurred by Lender as a result of such suit or joinder by Pledgor.

12. No course of dealing between Pledgor and Lender, nor any failure to exercise nor any delay in exercising, on the part of Lender, any right, power or privilege hereunder or under the Guarantees, the Loan Agreements, the Forbearance Agreement or other Loan Documents shall operate as a waiver of such right, power or privilege, nor shall any single or partial exercise

of any right, power or privilege hereunder or thereunder preclude any other or further exercise thereof or the exercise of any other right, power or privilege.

13. All of Lender's rights and remedies with respect to the Patents, Trademarks and Copyrights, whether established hereby or by the Guarantees, the Loan Agreements, the Forbearance Agreement or other Loan Documents or by any other agreements or Laws, shall be cumulative and may be exercised singularly or concurrently.

14. The provisions of this Agreement are severable, and if any clause or provision shall be held invalid and unenforceable in whole or in part in any jurisdiction, then such invalidity or unenforceability shall affect only such clause or provision, or part thereof, in such jurisdiction, and shall not in any manner affect such clause or provision in any other jurisdiction, or any clause or provision of this Agreement in any jurisdiction.

15. This Agreement is subject to modification only by a writing signed by the parties, except as provided in Paragraph 5.

16. The benefits and burdens of this Agreement shall inure to the benefit of and be binding upon the respective successors and permitted assigns of the parties, provided, however, that Pledgor may not assign or transfer any of its rights or obligations hereunder or any interest herein and any such purported assignment or transfer shall be null and void.

17. This Agreement shall be governed by and construed in accordance with the internal Laws of the Commonwealth of Pennsylvania without regard to its conflicts of law principles.

18. Pledgor irrevocably submits to the jurisdiction of any state or federal court sitting in the Commonwealth of Pennsylvania over any suit, action or proceeding arising out of or relating to this Agreement or any of the Loan Documents. Pledgor irrevocably waives, to the fullest extent permitted by law, any objection that it may now or hereafter have to the laying of the venue of any such suit, action or proceeding brought in any such court and any claim that any such suit, action or proceeding brought in any such court has been brought in an inconvenient forum. Final judgment in any such suit, action or proceeding brought in any such court shall be conclusive and binding upon Pledgor and may be enforced in any court in which Pledgor is subject to jurisdiction, by a suit upon such judgment, provided that service of process is effected upon Pledgor in one of the manners specified in the Loan Documents or as otherwise permitted by applicable Laws.

19. This Agreement may be executed in any number of counterparts, and by different parties hereto in separate counterparts, each of which, when so executed, shall be deemed an original, but all such counterparts shall constitute one and the same instrument. Pledgor acknowledges and agrees that a telecopy transmission to the Lender of the signature pages hereof purporting to be signed on behalf of Pledgor shall constitute effective and binding execution and delivery hereof by Pledgor.

20. EXCEPT AS PROHIBITED BY LAW, THE PLEDGOR AND THE LENDER HEREBY JOINTLY AND SEVERALLY WAIVE TRIAL BY JURY IN ANY ACTION OR PROCEEDING TO WHICH THE OBLIGORS AND THE LENDER MAY BE PARTIES, ARISING OUT OF OR IN ANY WAY PERTAINING TO (A) THIS AGREEMENT, (B) ANY OF THE LOAN DOCUMENTS, OR (C) THE PATENTS, TRADEMARKS AND COPYRIGHTS. THIS WAIVER CONSTITUTES A WAIVER OF TRIAL BY JURY OF ALL CLAIMS AGAINST ALL PARTIES TO SUCH ACTIONS OR PROCEEDINGS, INCLUDING CLAIMS AGAINST PARTIES WHO ARE NOT PARTIES TO THIS AGREEMENT. THE OBLIGORS AGREE THAT THEY WILL NOT ASSERT ANY CLAIM AGAINST THE LENDER OR ANY OTHER PERSON INDEMNIFIED UNDER THIS AGREEMENT ON ANY THEORY OF LIABILITY FOR SPECIAL, INDIRECT, CONSEQUENTIAL, INCIDENTAL OR PUNITIVE DAMAGES.

21. All notices, requests, demands, directions and other communications (collectively, "notices") given to or made upon any party hereto under the provisions of this Agreement shall be as set forth in Section 12 [Notices] of the JR&S Guaranty (Woolrich).

22.
