THIS AMENDED AND RESTATED CONFIRMATION OF PRIOR TRADEMARK ASSIGNMENTS is made this 21 day of July, 2014, by and among DHX Worldwide Holdings Limited, United Kingdom Company No. 1907241, with a principal place of business at 3 Shortlands, London, England W6 8PP ("DWHL-1907241"); DHX Worldwide Limited, United Kingdom Company No. 5786060, with a principal place of business at 3 Shortlands, London, England W6 8PP ("DWL-5786060"); and DHX-RD Developments Limited, United Kingdom Company No. 5786074, with a principal place of business at 3 Shortlands, London, England W6 8PP ("DDL-5786074").

WITNESSETH:

WHEREAS, the parties hereto wish to confirm and/or memorialize certain prior transactions and events which took place and are relevant to certain trademarks, including without limitation the trademarks, trademark registrations and pending trademark applications identified in Exhibit "A" hereto (collectively, the "Trademarks"); and

WHEREAS, in particular, the parties hereto wish to amend and restate the July 21, 2014 Confirmation of Prior Trademark Assignments recorded on July 21, 2014 at Reel 5326, Frames 671-704 of the assignment records of the United States Patent and Trademark Office,

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto set forth the following:

1. DWHL-1907241, DWL-5786060, and/or DDL-5786074 (operating under their original or prior names as identified more fully below) filed one or more of the Trademarks.

2. On or about February 7, 2000, DWHL-1907241 changed its name from its original name "Ragdoll Productions (UK) Limited" to "Ragdoll Limited." This change of name is recorded at Reel 2286, Frames 375-378 of the Trademark Office Assignment Branch records.

3. On or about September 5, 2006, DWHL-1907241 (operating under its prior name "Ragdoll Limited") assigned all of its rights in and to certain of the Trademarks (including all associated goodwill) to DDL-5786074 (operating under its original name "Ragdoll Worldwide Limited").

4. On or about July 31, 2008, DWHL-1907241 (operating under its prior name "Ragdoll Limited") executed a formal assignment document assigning all of its rights in and to certain of the Trademarks to DDL-5786074 (operating under its prior name "Ragdoll Worldwide Limited"). This formal assignment document is recorded at Reel 3828, Frames 533-537 of the Trademark Office Assignment Branch records.

5. On or about March 31, 2010, DDL-5786074 (operating under its original name "Ragdoll Worldwide Limited") assigned all of its rights in and to any of the Trademarks (including all associated goodwill) to DWL-5786060 (operating under its original name "Ragdoll Developments Limited").

6. On or about April 27, 2010, DWL-5786060 changed its name from "Ragdoll Developments Limited" to "Ragdoll Worldwide Limited," pursuant to the Certificate of Incorporation on Change of Name attached hereto (in photocopy form) as Exhibit "B".

7. On or about April 27, 2010, DDL-5786074 changed its name from "Ragdoll Worldwide Limited" to "Ragdoll Developments Limited," pursuant to the Certificate of Incorporation on Change of Name attached hereto (in photocopy form) as Exhibit "C".

8. On or about October 7, 2013, DWHL-1907241 changed its name from "Ragdoll Limited" to "DHX Worldwide Limited," pursuant to the Certificate of Incorporation on Change of Name attached hereto (in photocopy form) as Exhibit "D".

9. On or about October 7, 2013, DWL-5786060 changed its name from "Ragdoll Worldwide Limited" to "DHX-RD Worldwide Limited", pursuant to the Certificate of Incorporation on Change of Name attached hereto (in photocopy form) as Exhibit "E". This change of name is recorded at Reel 5129, Frames 735-738 and Reel 5143, Frames 359-362 of the Trademark Office Assignment Branch records.

10. On or about October 7, 2013, DDL-5786074 changed its name from "Ragdoll Developments Limited" to its current name "DHX-RD Developments Limited," pursuant to the Certificate of Incorporation on Change of Name attached hereto (in photocopy form) as Exhibit "F".

11. On or about June 17, 2014, DWHL-1907241 changed its name from "DHX Worldwide Limited" to its current name "DHX Worldwide Holdings Limited," pursuant to the Certificate of Incorporation on Change of Name attached hereto (in photocopy form) as Exhibit "G".

12. On or about June 17, 2014, DWL-5786060 changed its name from "DHX-RD Worldwide Limited" to its current name "DHX Worldwide Limited," pursuant to the Certificate of Incorporation on Change of Name attached hereto (in photocopy form) as Exhibit "H".

13. The parties hereto hereby ratify and confirm each of the transactions and events referenced in paragraphs 1 through 12 hereof.

14. The parties agree to prepare, execute and deliver such further documents, and to perform such further acts, as are necessary or appropriate to implement, effectuate or carry out

the terms and provisions of this Confirmation of Prior Trademark Assignments, or to further confirm and/or memorialize the transactions and events referenced herein.

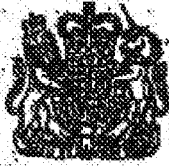
