**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

WHEREAS, **ESSAR STEEL ALGOMA INC.**, a Canadian corporation with its principal office located at 105 West Street, Sault Ste., Marie, Ontario, Canada P6A 7B4 (the "**Grantor**"), entered into a certain trademark security agreement, dated September 20, 2012 (the "**Trademark Security Agreement**") with **DEUTSCHE BANK TRUST COMPANY AMERICAS**, a New York banking corporation with its principal office located at 60 Wall Street, New York, New York, 10005 (the "**Collateral Trustee**"), notice of which was recorded on September 24, 2012 at the United States Patent and Trademark Office at Reel 4865, Frame 0929.

WHEREAS, Grantor granted the Collateral Trustee, under the terms of the Trademark Security Agreement, a continuing security interest (the "**Security Interest**") in favor of the Collateral Trustee, in and to certain of Grantor's intellectual property, including without limitation, the trademarks listed in **Schedule A** (collectively, the "**Trademarks**") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, as well as all proceeds and claims based on past, present, or future infringement.

WHEREAS, the Grantor requests a termination and release of the Security Interest granted and recorded against the Trademarks and the Collateral Trustee has agreed to terminate and release the Security Interest in all such Trademarks as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Trustee, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all liens, security interests, right, title and interest in the intellectual property of the Grantor, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest, that the Collateral Trustee may have. The Collateral Trustee further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantor and its successors and assigns in association with the Security Interest, and hereby releases the Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.

This release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
