**ARTICLES OF ORGANIZATION**  
 Professional Limited Liability Company  
 (Conversion of Business Entity)

Pursuant to §§ 57C-2-01(e), 57C-9A-01 and Chapter 55B of the General Statutes of North Carolina, the undersigned does hereby submit these Articles of Organization for the purpose of forming a professional limited liability company pursuant to a conversion of another business entity.


