TRADEMARK ASSIGNMENT (UNITED STATES)

WHEREAS, COMBAT SPORTS INC., a Canadian corporation with its principal place of business at 5390 Canotek Road, Unit 20, Ottawa, K1J 1H8 Ontario, Canada (hereafter "ASSIGNOR"), has heretofore made commercial use of the trademark COMBAT for which it owns United States trademark registration number 2,851,390 in association with baseball bats in International Class 28 (hereafter referred to as "the Trademark"); and,

WHEREAS, BPS Diamond Sports Corp., a corporation incorporated under the laws of Ontario and having its principal place of business at 5390 Canotek Road, Unit 20, Ottawa, K1J 1H8 Ontario, Canada (hereafter "ASSIGNEE"), desires to acquire the entirety of such right, title and interest in and to the Trademark, together with the goodwill of the business symbolized by the Trademark, which ASSIGNOR now possesses.

WHEREAS BDO CANADA LTD. (the "RECEIVER") was appointed the court-appointed receiver of the assets, properties and undertakings of ASSIGNOR pursuant to an order of the court dated February 25, 2013 with the power to sell the assets, properties and undertakings of ASSIGNOR.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, RECEIVER hereby sells, transfers, conveys, assigns and delivers to ASSIGNEE the entirety of ASSIGNOR'S rights, title and interests in and to the Trademark which ASSIGNOR now possesses, together with the goodwill of the business symbolized by the Trademark and that portion of the business of ASSIGNOR to which the Trademark pertains, including the right to sue and recover damages and other remedies for any infringements, dilutions and/or other violations thereof, including past infringements, dilutions and/or other violations.

IN WITNESS WHEREOF, RECEIVER has caused this Trademark Assignment to be executed by its duly authorized representative on the date set forth below.

BDO CANADA LIMITED, in its capacity as the Court-appointed receiver of the assets, undertakings and properties of Combat Sports Inc. and Combat Sports, Inc. and not in its personal or corporate capacity
