INTELLECTUAL PROPERTY SECURITY AGREEMENT

Intellectual Property Security Agreement, dated as of October 31, 2013 by DHX Media Ltd. (together with its successors and permitted assigns, the "**Borrower**") and certain of its Restricted Subsidiaries (as defined in the senior secured credit agreement (as amended, supplemented, restated, extended, renewed, continued or superseded from time to time, the "**Credit Agreement**") dated as of October 22, 2012 among, *inter alia*, the Borrower, the Restricted Subsidiaries, Royal Bank of Canada, as administrative agent, and the financial institutions from time to time party thereto, as lenders) listed on the signature pages hereto (each, together with its successors and permitted assigns, a "**Grantor**"), in favour of Royal Bank of Canada as administrative agent (together with any successors in such capacity, the "**Agent**").

WHEREAS, in connection with the Credit Agreement, each Grantor is party to a Security Agreement dated as of October 22, 2012 (as amended, supplemented, restated, extended, renewed, continued or superseded from time to time, the "**Security Agreement**") in favour of the Agent pursuant to which each Grantor has granted to the Agent a security interest in all of such Grantor's right, title and interest in, to and under, among other property, certain intellectual property of such Grantor as security for the timely payment or performance of the Secured Obligations;

WHEREAS, each Grantor has agreed to execute this Intellectual Property Security Agreement for recording with the Canadian Intellectual Property Office;

WHEREAS, with respect to the Trademarks, each Grantor has adopted, used, is using or intends to use, and is the owner of any Trademarks that each such Grantor has agreed to pledge and grant to the Agent, and with respect to the Collateral each Grantor is the owner of any Collateral that each such Grantor has agreed to pledge and grant to the Agent, and, and any registrations, recordings and applications associated therewith;

NOW, THEREFORE, in consideration of the premises and to induce the Agent, for the benefit of the Secured Creditors, to enter into the Credit Agreement, each Grantor hereby agrees with the Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Intellectual Property Collateral. As continuing security for the payment and performance of each of its Secured Obligations, each Grantor hereby pledges and grants to the Agent for the benefit of the Secured Creditors a lien on and security interest in and to all of its right, title and interest in, to and under all the following Collateral of such Grantor:

(a) any and all Copyrights, whether now owned or at any time hereafter acquired, of such Grantor, whether registered or unregistered and whether published or unpublished, located in the United States of America, including the Copyrights of such

Grantor registered with the United States Copyright Office, including without limitation the Copyrights that are listed on Schedule I hereto owned by such Grantor, and all registrations, recordings, and pending applications associated therewith, together with any and all reissues, renewals, and extension thereof, and any and all proceeds thereof, including, but not limited to, any and all causes of action that may exist by reason of past, present, or future infringement thereof;

(b) any and all Trademarks, whether now owned or at any time hereafter acquired, of such Grantor, that are registered with, or for which applications for registration have been filed with, the United States Patent and Trademark Office or are unregistered, including without limitation the Trademarks listed on the attached Schedule I hereto owned by such Grantor, and all registrations and pending applications associated therewith, together with the goodwill of the business symbolized by the Trademarks, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof;

(c) any and all patents, whether now owned or at any time hereafter acquired, of such Grantor, including without limitation the right, title and interest, if any, held by such Grantor in and to the patents listed on Schedule I attached hereto; and

(d) any and all other Intellectual Property, whether now owned or at any time hereafter acquired, of such Grantor.

SECTION 3. Security Agreement. The security interests granted pursuant to this Intellectual Property Security Agreement are granted in conjunction with the security interest granted to the Agent pursuant to the Security Agreement and each Grantor hereby acknowledges and affirms that the rights and remedies of the Agent with respect to the security interest in the Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Intellectual Property Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control unless the Agent shall otherwise determine.

SECTION 4. Representations and Warranties. Each Grantor hereby represents and warrants that:

(a) The attached Schedule I sets forth all of each of the Grantors' Trademarks, patents and Copyrights applied for or registered with the United States Patent and Trademark Office or United States Copyright Office, as applicable, including the registration, application, or publication number as applicable; and

(b) None of the Grantors owns or has rights in any Trademarks, patents, Copyrights or other intellectual property which have been applied for or registered with the United States Patent and Trademark Office or United States Copyright Office, as applicable, except as detailed in Schedule I.

SECTION 5. Termination. Upon the payment in full of the Secured Obligations and termination of the Security Agreement, the Agent shall execute, acknowledge, and deliver to each Grantor an instrument in writing in recordable form releasing the collateral pledge, grant, assignment, lien and security interest in the Collateral under this Intellectual Property Security Agreement.


SECTION 6. Counterparts. This Intellectual Property Security Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Intellectual Property Security Agreement by signing and delivering one or more counterparts.

SECTION 7. Governing Law. This Intellectual Property Security Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario.


