**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), is dated as of November 14, 2014, and made by Deutsche Bank AG New York Branch, as Collateral Agent, having an office at 60 Wall Street, New York, New York 10005 ("Deutsche Bank") to (i) Ceridian LLC, a Delaware limited liability company (successor in interest to Ceridian Corporation, a Delaware corporation), whose principal place of business is 3311 E. Old Shakopee Road, Minneapolis, Minnesota 55425, (ii) Ceridian Benefits Services, Inc., a Florida corporation, whose principal place of business is 3311 E. Old Shakopee Road, Minneapolis, Minnesota, 55425 and (iii) Comdata, Inc., a Delaware corporation (successor in interest to Ceridian Stored Value Solutions, Inc., a Delaware corporation, and Comdata Network, Inc., a Maryland corporation), whose principal place of business is 5301 Maryland Way, Brentwood, Tennessee 37027 (each a "Grantor" and collectively, the "Grantors").

WHEREAS, pursuant to (i) that certain Trademark Security Agreement, dated as of July 10, 2012, by each Grantor in favor of Deutsche Bank, and (ii) that certain Security Agreement, dated as of July 10, 2012, among, *inter alios*, each Grantor and Deutsche Bank, a lien on and security interest in all right, title and interest in and to any and all of each Grantor's rights (the "Interests") in certain collateral then owned or thereafter acquired by such Grantor was granted by each Grantor to Deutsche Bank in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Interests were recorded in the Trademark Assignment Recordation Branch of the United States Patent and Trademark Office on August 10, 2012, at Reel 4839 and Frame 0525;

WHEREAS, Deutsche Bank acknowledges full performance by each Grantor of the Obligations; and accordingly Deutsche Bank now desires to terminate and release the Interests; and to reconvey any and all rights in the Trademark Collateral to the Grantors; and

NOW, THEREFORE, for good and valuable consideration, Deutsche Bank hereby states as follows:

1. Definitions. The term "Trademark Collateral" shall mean all right, title or interest in or to any and all of the following assets and properties now owned or at any time hereafter acquired by each Grantor and wherever located or in which such Grantor now has or at any time in the future may acquire any right, title or interest: (a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office, and all extensions or renewals thereof, including those listed on Schedule A (the "Trademarks"), (b) all goodwill associated with or symbolized by the Trademarks; (c) all assets, rights and interests that uniquely reflect or embody the Trademarks; (d) the right to sue third parties for past, present and future infringements of any Trademark; and (e) all proceeds of and rights associated with the foregoing. Capitalized terms used herein without definition are used as defined in the Security Agreement, dated as of July 10, 2012, made by, *inter alios*, each Grantor in favor of Deutsche Bank.

2. Release of Security Interest. Deutsche Bank hereby terminates the Interests and terminates releases, relinquishes and discharges the Interests in the Trademark Collateral, without recourse, representation or warranty.

Deutsche Bank hereby authorizes the Grantors, or the Grantors' authorized representatives to: (a) record this Termination with the United States Patent and Trademark Office and/or any other applicable governmental office or agency, and (b) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the Interests of Deutsche Bank in the Trademark Collateral. Deutsche Bank agrees to execute and deliver to the Grantors all other instruments and other documents as may be necessary or proper to release the Interests in the Trademark Collateral which had been granted under the Trademark Security Agreement.
