RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release") is made and effective as of November 19, 2014, by First New England Capital III, L.P., a Delaware limited partnership, located at 998 Farmington Ave., Suite 216, West Hartford, CT 06107, in its capacity as collateral agent ("FNEC"), in favor of Cecilware Corporation, a Delaware corporation, located at 4003 Collins Lane, Louisville, KY 40245 ("Cecilware").

WHEREAS, the Security Agreement has been recorded with the U.S. Patent and Trademark Office at Reel 4082/0646; and

WHEREAS, FNEC has agreed to release such Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, FNEC hereby states as follows:

1. FNEC, on behalf of itself, its successors, legal representatives and assigns, terminates, releases and discharges its interest in and to the Trademarks, and all other right, title, and interest in and to the Trademarks.

2. FNEC agrees to execute, acknowledge, procure and deliver to Cecilware any and all further documents or instruments and do any and all further acts which Cecilware (or its respective agents, designees or assignees) reasonably request in order to confirm, effectuate or record this Release and Cecilware's (or its assignees') right, title and interest in and to the Trademarks.
