The following articles of merger are being submitted for filing in accordance with Section 14-11-904 of the Georgia Limited Liability Company Act (the "Act").

STREAMLINE HEALTH, INC., an Ohio corporation, does hereby certify as follows:

**FIRST:** These Articles of Merger shall be effective January 31, 2014 (the "Effective Date").
