**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION**

of

MANAGERPLUS SOLUTIONS, LLC

**FORMERLY KNOWN AS
QQUEST ASSET MANAGEMENT SERVICES, LLC**

The undersigned manager of ManagerPlus Solutions, LLC, formerly known as Qquest Asset Management Services, LLC, a Utah limited liability company (Utah Entity No. 5638787-0160), hereby amends and restates the Articles of Organization for Manager Plus Solutions, LLC, as follows. The amendment and restatement of the Articles of Organization was adopted and approved by the members and the managers on December 11, 2012.

**ARTICLE I
NAME**

The name of this limited liability company is ManagerPlus Solutions, LLC (the "Company").

**ARTICLE II
DURATION**

The period of the Company's duration is Ninety Nine (99) years from the date of filing of the Company's original Articles of Organization, or until sooner dissolved in accordance with applicable Utah law, unless extended by the unanimous consent of all members.

**ARTICLE III
PURPOSES**

The purposes for which the Company is organized are:

(a) To conduct any or all lawful business for which limited liability companies may be organized under the Utah Revised Limited Liability Company Act as from time to time authorized by the managers of the Company; and

(b) In general, to do any and all things and exercise any and all powers which may now or hereafter be lawful for the Company to do or exercise under and in accordance with the laws of the State of Utah.
