FULL RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, VENDORMATE HOLDING COMPANY, a Delaware corporation (“Holdings”), VENDORMATE, INCORPORATED, a Georgia corporation (the “Borrower”; Borrower, together with Holdings, are, individually, a “Grantor”, and collectively, the “Grantors”), granted to SILICON VALLEY BANK, (the “Bank”) a security interest in, among other things, certain of the Grantors’ trademarks listed on Schedule I attached hereto (the “Subject Trademarks”) pursuant to that certain Trademark Security Agreement, dated as of December 21, 2010 and recorded with the United States Patent and Trademark Office on December 5, 2012 at Reel 4913, Frame 0640; and

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Bank hereby (1) releases, discharges and relinquishes its security interest in the Subject Trademarks, (2) reassigns to the Grantors all right title, and interest that it may have had in the Subject Trademarks, including the goodwill associated with the Subject Trademarks, any and all applications or registrations therefor, and the right to sue for past, present and future infringements, and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits, and (3) acknowledges and agrees that any right, title or interest of Bank in the Grantors’ intellectual property, including the Subject Trademarks, does hereby cease and become void.
