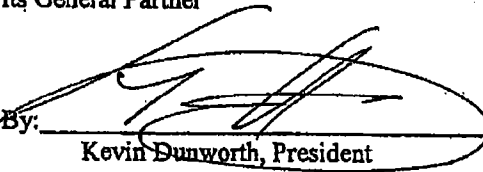
Pursuant to the provisions of Section 10.154 of the Texas Business Organizations Code, the undersigned Texas limited partnership, SpineSmith Partners, L.P., adopts the following Certificate of Conversion for the purpose of converting into SpineSmith Holdings, LLC, a Delaware limited liability company, and hereby certifies as follows:

1. The name of the converting limited partnership (the "Partnership") is SpineSmith Partners, L.P.
2. The jurisdiction of formation of the Partnership is Texas.
3. The date of formation of the Partnership is December 29, 2005.
4. The file number, if any, issued to the Partnership by the Secretary of State is 800592180.

10. The approval of the plan of conversion was duly authorized by all action required by the laws of the jurisdiction of formation and the governing documents of the Partnership.
11. This document becomes effective when the document is accepted and filed by the Secretary of State.
12. In lieu of providing a tax certificate from the Comptroller of Public Accounts, the Company is liable for the payment of any franchise taxes.
