## FULL RELEASE AND RECONVEYANCE OF SECURITY INTERESTS

This Full Release and Reconveyance of Security Interests is granted by WILMINGTON TRUST, NATIONAL ASSOCIATION (hereinafter, the "Secured Party") in favor of COAST WIRE AND PLASTIC TECH, LLC, a Delaware limited liability company (the "Grantor Party").

The Secured Party hereby authorizes and requests all agencies and any other applicable government officer with whom any security interest in or to any or all of the Collateral has been recorded or registered, including, without limitation, the Commissioner for Patents and Trademarks with regard to any trademark, trademark application, and mark included in the Collateral, to record this Full Release and Reconveyance of Security Interests.

This Full Release and Reconveyance of Security Interests shall be governed by and construed in accordance with the laws of the State of New York without regard to any principles of conflicts of law.
