**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

WHEREAS **FIRTH RIXSON LIMITED**, a limited liability company incorporated in England and Wales with registered number 00230737 and having its registered office at Firth Rixson House, 26a Atlas Way, Sheffield, South Yorkshire, United Kingdom S4 7QQ (the “Grantor”), entered into a certain trademark security agreement dated December 20, 2007 (the “Trademark Security Agreement”) with **LEHMAN BROTHERS INTERNATIONAL (EUROPE)** (“Original Grantee”), notice of which was recorded on March 18, 2008 at the United States Patent and Trademark Office at Reel 3742, Frame 0664.

WHEREAS, Grantor granted the Original Grantee, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Original Grantee, in and to certain of Grantor’s intellectual property, including the trademarks listed in **Schedule A** and all of the goodwill of the business connected with the use of, and symbolized by the trademarks, as well as all proceeds and claims based on past, present, or future infringement (collectively, the “Trademark Collateral”).


WHEREAS, **LLOYDS BANK PLC**, a United Kingdom public limited company with offices at 25 Gresham Street, London, United Kingdom EC2V 7HN (the “Current Grantee”) entered into an Assignment of Security Interest in United States Trademark with the Original Grantee, notice of which was recorded on July 1, 2009 at the United States Patent and Trademark Office at Reel 4015, Frame 0536, pursuant to which Original Grantee granted and assigned the Security Interest in all of Original Grantee’s right, title and interest in, to and under the Trademark Collateral.

WHEREAS, the Current Grantee has agreed to terminate and release its security interest in the Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Current Grantee, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the intellectual property of the Grantor, including the Trademark Collateral, and all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest and any other liens.
