RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made as of this 10th day of November 2014, by LEGG MASON SBIC MEZZANINE FUND, L.P., a Delaware limited partnership, in its capacity as administrative agent ("Agent"), in favor of IMPACT CONFECTIONS, INC., a New Mexico corporation, and MELSTER CANDIES, INC., a Wisconsin corporation (collectively, the "Companies").

WHEREAS, Agent and Companies are parties to a Security Agreement dated January 15, 2008, pursuant to which Companies granted to Agent a security interest in and to Trademarks (as defined in the Security Agreement), together with the goodwill of the business symbolized by the Companies' Trademarks;

WHEREAS, Agent and Companies executed a Trademark Security Agreement dated January 15, 2008, that was recorded with the United States Patent and Trademark Office on January 17, 2008 at reel/frame 3699/0108 (the "Trademark Security Agreement") against certain trademarks identified on Schedule A hereto;

WHEREAS, Companies have satisfied all of the obligations under the Security Agreement and have requested that the Agent terminate and release its security interests in and liens on the Trademark Collateral (as defined below) as herein provided;


WHEREAS, all capitalized terms used herein shall have the meaning ascribed to them in the Security Agreement, unless otherwise defined in this Release;
