**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of November 18, 2014 ("Effective Date") by General Electric Capital Corporation, as agent (the "Agent"), in favor of Main Steel Polishing Company, Inc. (the "Grantor").

WHEREAS, Grantor and the Agent entered into that certain Guaranty and Security Agreement by and between Grantor, the Agent and the Lender parties thereto dated March 26, 2012 (the "Guaranty and Security Agreement"), wherein Grantor granted to the Agent a lien on and security interest in all of its right, title and interest in, to and under the assets of Grantors;

WHEREAS, pursuant to the Guaranty and Security Agreement, that certain Trademark Security Agreement dated March 26, 2012 (the "Trademark Security Agreement") was entered into by Grantor and the Agent to record the security interest with respect to the Trademarks (as defined in the Guaranty and Security Agreement) of Grantor, including those items set forth on Schedule A hereto (collectively, the "Trademark Collateral") and was recorded with the United States Patent and Trademark Office on March 27, 2012, at Reel 004744, Frame 148; and

WHEREAS, Grantor and Agent have agreed to a specific release of the security interest granted and recorded against the items set forth on Schedule A hereto (the "Released Marks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby on behalf of itself and the Lenders (i) releases and re-assigns to Grantor any and all liens, security interests, right, title and interest it may have in, to and under the Released Marks, together with the goodwill of the business symbolized thereby; (ii) agrees that it shall execute all other documents and do all other acts necessary to relinquish and effect the release of such rights to Grantor; and (iii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Agent's rights under the Guaranty and Security Agreement with respect to the Released Marks.

This Release may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
