DECLARATION OF DIEGO F. CALDERIN CONCERNING ANEXINET CORP.'S
TRADEMARK REGISTRATIONS

Commissioner:

1. I am over 18 years of age and able to enter into this Declaration.
2. I am the President of Anexinet Corp. and I am authorized to act and speak on its behalf and have knowledge concerning the events discussed herein.
3. On January 25, 2001, Anexinet Corp. had filed on its behalf a trademark application, which was granted U.S. Application Serial No. 76/199,191, for ANEXINET (the "191 Application"). Due to a clerical error, this application was inadvertently filed in the name of Anexinet, Inc. when, in reality, the '191 Application should have been filed in the name of Anexinet Corp. The '191 Application subsequently registered as U.S. Trademark Registration No. 2608212 on August 13, 2002.
4. Similarly, on September 2, 2008, I filed on Anexinet's behalf a trademark application, which was granted U.S. Application Serial No. 77/560,391, for WHERE LEADING EDGE TECHNOLOGY MEETS COMPETITIVE ADVANTAGE (the "391 Application"). Due to a clerical error, this application was inadvertently filed in the name of Anexinet when, in reality, the '391 Application should have been filed in the name of Anexinet Corp. The '391 Application subsequently registered as U.S. Trademark Registration No. 3602230 on April 7, 2009.
5. Similarly, on July 8, 2004, I filed on Anexinet's behalf a trademark application, which was granted U.S. Application Serial No. 78/447,446, for NEAR-SITE (the "446

Application"). Due to a clerical error, this application was inadvertently filed in the name of Anexinet when, in reality, the '446 Application should have been filed in the name of Anexinet Corp. The '446 Application subsequently registered as U.S. Trademark Registration No. 2997711 on September 20, 2005.

6. Accordingly, I respectfully request that the U.S. Patent and Trademark Office update the Registrant information for the above-referenced registrations to reflect that Anexinet Corp. is the correct owner of these registrations.

7. I declare that all statements made herein are of my own knowledge and are true and that all statements made on information and belief are true and further that these statements were made with the knowledge that willful false statements and the like are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of this application and any registration resulting therefrom.
