TRADEMARK ASSIGNMENT

This Trademark Assignment, dated November 25, 2014, is made by and between COSCO MANAGEMENT, INC., a Delaware Corporation located at 300 Delaware Avenue, Suite 1285, Wilmington, DE 19801 ("Assignor"), and DOREL JUVENILE GROUP, INC., a Massachusetts Commonwealth Corporation located at 25 Forbes Boulevard, Suite 4, Foxboro, MA 02035 ("Assignee");

WHEREAS, Assignor is the owner of the entire right, title and interest in and to the trademarks listed in Schedule A attached hereto (the "Trademarks");

WHEREAS, Assignee is desirous of acquiring the entire right, title and interest in and to the Trademarks; and

NOW, THEREFORE, for and in consideration of the sum of ten US dollars (\$10.00) and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Section 1.1 Assignment. Assignor hereby assigns to Assignee all right, title and interest in and to the Trademarks and the registrations therefor and throughout the world together with all common law rights related thereto, with the goodwill of the business symbolized by the Trademarks, along with the right to sue and recover for, and the right to profits, penalties or damages due or accrued arising out of or in connection with any and all past, present and future infringements or dilution of or damage or injury to the Trademarks or such represented goodwill.

Section 1.2 Acknowledgement. Assignor hereby acknowledges and agrees that from and after the execution date hereof, as between the Parties, Assignee shall be the exclusive owner of the Trademarks.

Section 1.3 Cooperation. This Assignment has been executed and delivered by the Assignor to be used for recording the Assignment herein with the appropriate government entity. At Assignee's sole cost and expense, Assignor shall execute and deliver such other documents and take all other actions which Assignee, its successors and/or assigns may reasonably request to effect the terms of this Assignment and to perfect Assignee's right, title and interest in and to the Trademarks, including, without limitation, its recordation in relevant state and national trademark offices.

Section 1.4 General Provisions. This Assignment constitutes the entire understanding and agreement of the parties hereto with respect to the subject matter hereof and supersedes all prior and contemporaneous agreements or understandings, inducements or conditions, express or implied, written or oral, between and among the parties with respect hereto. This Assignment may not be supplemented, altered, or modified in any manner except by a writing signed by all parties hereto. The failure of any party to enforce any terms or provisions of this Assignment shall not waive any of its rights under such terms or provisions. This Assignment shall bind and inure to the benefit of the respective parties and their assigns, transferees and successors.

Section 1.5 Counterparts. This Assignment may be executed in counterparts, each of which will be an original as regards any party whose signature appears thereon and both of which together will constitute one and the same instrument.




