RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

November 28, 2014

WHEREAS, pursuant to (i) that certain Intellectual Property Security Agreement, dated as of August 29, 2013 (as amended or supplemented from time to time, the “*IP Security Agreement*”), (i) recorded in the United States Patent and Trademark Office on August 29, 2013 at Reel/Frame 5099/0695 against the Trademarks and at Reel/Frame 31123/0671 against the Patents and (ii) filed in the United States Copyright Office on August 30, 2013, DEMAND MEDIA, INC., a Delaware corporation (the “*Releasee*”) granted and pledged to SILICON VALLEY BANK (“*Releasor*”), for the ratable benefit of the Secured Parties, a security interest in all of Releasee’s right, title and interest in, to and under its Intellectual Property (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A, B and C hereto) (collectively, the “*IP Collateral*”); and

WHEREAS, Releasee has requested and Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office and the United States Copyright Office evidencing and effecting the release, relinquishment and discharge of its security interest in the IP Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Administrative Agent hereby agrees as follows:

1. *Defined Terms.* All capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

2. *Release of Security Interest.* Administrative Agent hereby, without any representation and warranty and without any recourse to Administrative Agent, releases, relinquishes and discharges its security interest in the IP Collateral.
