CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS, New England Brickmaster Windows & Exteriors, Inc., a Massachusetts corporation, having its principal place of business in Tewksbury, Massachusetts, ("NEBW") has adopted, used, and is the owner of record of the mark listed on Schedule A attached hereto (the "Mark")

and;

WHEREAS, on April 7, 2009 NEBW filed a voluntary petition for relief under the provisions of Chapter 7 of the Bankruptcy Code (11 U.S.C. Section 101, et. seq.) and on April 20, 2009 Anne J. White was duly appointed as the Chapter 7 Trustee of NEBW and is qualified and acting Chapter 7 Trustee of NEBW ("Assignor"); and

WHEREAS, the Assignor conveyed all of NEBW's rights, title and interest in and to the Mark to Noah Goldstein of Waban, Massachusetts ("Assignee") by a Bill of Sale dated September 30, 2009 delivered pursuant to the Order entered by the United States Bankruptcy Court granting the Trustee's Motion Authorizing Private Sale; and

WHEREAS, Assignee intended to acquire and Assignor by delivery of the Bill of Sale intended to convey the entire right, title and interest in and to the Mark, any registrations and applications for registration thereof, and the goodwill of the business symbolized thereby.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, said ASSIGNOR does hereby confirm that effective September 30, 2009, Assignor transferred, conveyed, and assigned unto the said ASSIGNEE all right, title and interest in and to the Mark throughout the world, together with: (i) the entire business or portion thereof to which the Mark pertains; (ii) the goodwill of the business symbolized by and associated with the Mark; (iii) all registrations and applications for registration of the Mark, including without limitation those identified on the attached Schedule A; and (iv) all rights to all past, present and future claims for infringement or dilution of, or damage or injury to, the Mark including without limitation the right to grant licenses, to bring lawsuits or administrative actions, and to recover damages and profits for any past, present and future infringement, whether known or unknown, now existing or hereafter arising.
