**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of November 19, 2014 (“Release”), is made by Wells Fargo Bank, National Association (the “Secured Party”) in favor of DAS Companies, Inc. and DAS Brands, LLC (collectively the “Debtor”).

WHEREAS, the Secured Party entered into various loan agreements that required Debtor to grant the Secured Party a security interest in certain of Debtor’s assets, including, without limitation, its patents and patent applications and trademarks and trademark applications and goodwill, all of which were secured by an Intellectual Property Security Agreement dated as of the 29th day of October, 2002, as amended and modified on the 24th day of February 2012 and on the 27th day of March, 2013;

WHEREAS, the Intellectual Property Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on October 30, 2002 at Reel 2606 Frame 0743, October 30, 2002 at Reel 2606 Frame 0755, April 2, 2013 at Reel 4996 Frame 0242 and March 9, 2012 at Reel 4734 Frame, 0158; and

WHEREAS, the Secured Party desires to release its security interest and terminate the Intellectual Property Security Agreement.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Secured Party, on behalf of itself and the Lenders, and Debtor (the “parties”) agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Intellectual Property Security Agreement.

SECTION 2. Termination and Release. Secured Party, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation, collateral assignment, and lien on and security interest in and to the trademarks listed on Schedule A attached hereto; and

(b) authorizes the recordation of this Release with the USPTO.

SECTION 3. Acknowledgement. The release of security interest granted herein expressly does not include a release of the security interest granted in any trademarks not listed on Schedule A.

IN WITNESS WHEREOF, the Secured Party has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
