Pursuant to Section 4-27-1108 of the Arkansas Business Corporation Act (the "Act"), the undersigned executes the following Articles of Merger:

1. The name of the surviving corporation is Ascent Acquisition Corporation, an Arkansas corporation ("Surviving Corporation").
2. The name of the subsidiary companies are Pediatric Specialty Care, Inc., Child & Youth Pediatric Day Clinics, Inc. and Med Properties, Inc., each an Arkansas corporation (the "Subsidiary Companies").
3. The Surviving Corporation owns 100% of the outstanding capital stock of the Subsidiary Companies.
4. The board of directors of Surviving Corporation adopted the Agreement and Plan of Merger on December 21, 2013.
5. Pursuant to Section 4-27-1108 of the Act, shareholder approval is not required.
6. The Merger shall become effective at 10:54 p.m. CST on December 31, 2013.
7. The Agreement and Plan of Merger is on file at 830 Crescent Centre Drive, Suite 610, Franklin, Tennessee 37067, the office of the Surviving Corporation.
8. A copy of the Agreement and Plan of Merger will be furnished by the Surviving Corporation on request, without cost, to any shareholder of the Subsidiary Companies.
