DECLARATION

I, Deborah K. Squiers, does hereby state and declare as follows:

1. I am outside counsel to Franklin Foods, Inc. and Franklin Foods Holdings, Inc. in connection with trademark matters.

2. Franklin Foods Holdings, Inc. is the record owner of **US Registration No. 1262577** for the mark HAHN'S ("HAHN'S Registration").

3. At Reel 3262/Frame 0073, Sorrento Lactalis Arpin, Inc. ("Sorrento Lactalis") mistakenly included the HAHN'S Registration in a recordal of an assignment from Sorrento Lactalis to Lactalis USA Commercial, Inc. ("Lactalis USA"). Neither Sorrento Lactalis nor Lactalis USA owned the HAHN'S Registration, and the HAHN'S Registration was not listed in the marks being assigned.

4. On November 12, 2013, Lactalis USA filed a corrective assignment at Reel 005152/Frame 0742 to reflect the mistaken inclusion of the HAHN'S Registration in its recordal at Reel 3262/Frame 0073. A copy of such filing is attached hereto as Exhibit A.

5. Lactalis USA filed the corrective assignment at Reel 005152 / Frame 0742 against all the registrations listed in the assignment but failed to file it against the HAHN'S Registration.

6. Accordingly, Registrant Franklin Foods Holdings, Inc. requests that the USPTO correct the records of the Assignment Branch to indicate that the Sorrento Lactalis to Lactalis USA *should not* have been recorded against the HAHN'S Registration.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Marks, together with (1) the goodwill of the business relating to the Products in respect upon which the Marks are used and for which they are registered or pending; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks; and (3) all rights to sue for past, present and future infringements or misappropriations of the Marks.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks and the Property.

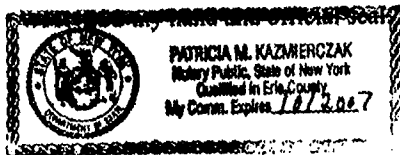
