**RELEASE OF SECURITY INTERESTS**

WHEREAS, The Electric Controller and Manufacturing Company, L.L.C, a Delaware limited liability company with an address of 8821 Garners Ferry Road, Hopkins, South Carolina 29601 (hereinafter referred to as "Pledgor"), and NBSC, a division of Synovus Bank, as successor in interest to The National Bank of South Carolina, with an address of Post Office Box 1457, Columbia, South Carolina 29202 (hereinafter referred to as "NBSC") entered into certain promissory notes, a security agreement, a patent security agreement (the "Patent Security Agreement"), a trademark security agreement (the "Trademark Security Agreement"), and other related documents on or about October 9, 2003 and October 31, 2003 (the "Security Agreement Documents"); and


WHEREAS, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on November 14, 2003 at Trademark Reel 2866, Frame 0733; and

WHEREAS, Pledgor's obligations to NBSC that were secured by the collateral subject to the Security Agreement Documents have been paid or satisfied in full on or about July 26, 2006, and this Release is intended to be effective as of that date.

NOW THEREFORE, for good and valuable consideration and pursuant to Paragraph 10 of the Trademark Security Agreement and Paragraph 10 of the Patent Security Agreement, NBSC hereby agrees that the Security Agreement Documents and all products and proceeds thereof shall be and hereby are released and shall no longer have any force or effect. NBSC further authorizes and instructs the U.S. Patent and Trademark Office to discharge the Trademark Security Agreement on its records.
