GRANT OF A SECURITY INTEREST – PATENTS, TRADEMARKS

WHEREAS, On-Site Analysis, Inc., a Delaware corporation (the “Grantor”), holds all right, title and interest in the patents, patent applications and trademarks (the “Patents, Patent Applications and Trademarks”) listed on the attached Schedule A, which patents have been issued by or patent applications and trademarks filed with the United States Patent and Trademark Office;

WHEREAS, the Grantor has entered into a Supplement to Security Agreement dated as of November 28, 2014, pursuant to which it became a party to an Amended and Restated Security Agreement, dated as of September 18, 2013, as amended by that certain Amendment No. 1 to Amended and Restated Credit Agreement and Other Loan Documents, dated as of April 1, 2014 (as amended, restated, supplemented, modified or otherwise changed from time to time, the “Security Agreement”), in favor of TriState Capital Bank, a Pennsylvania state chartered bank, as agent for certain Lender Parties referred to therein (in such capacity the “Grantee”); and

WHEREAS, pursuant to the Security Agreement, the Grantor has granted to the Grantee a continuing security interest in all right, title and interest of the Grantor in, to and under the Patents and Patent Applications and any patents that may issue therefrom, and Trademarks, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the “Collateral”), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement); and


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor does hereby grant to the Grantee a continuing security interest in the Collateral to secure the prompt payment in full when due, whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise, all Secured Obligations.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Grantee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
