RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated September 30, 2014 by FIFTH THIRD BANK, an Ohio banking corporation ("*Fifth Third*"), with its mailing address at 1000 Town Center, Suite 1400, Southfield, Michigan 48075, acting as administrative agent hereunder for the Secured Creditors as defined in the Agreement referred to below (Fifth Third acting as such administrative agent in such capacity being hereinafter referred to as "*Administrative Agent*");

WITNESSETH:

WHEREAS, Technology Investment Partners, L.L.C., a Michigan limited liability company ("*Debtor*"), with its mailing address at 40950 Woodward Ave., Bloomfield Hills, Michigan 48304, and Administrative Agent were parties to a certain Trademark Collateral Agreement dated August 9, 2011 between Debtor and Administrative Agent which was recorded in the United States Patent and Trademark Office on August 9, 2011 at Reel 4600, Frame 0959 (the "*Agreement*"), pursuant to which Debtor granted to Administrative Agent, a security interest in, among other things, the trademarks, trademark registrations, and trademark application listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and

WHEREAS, Debtor has requested that Administrative Agent release its security interests in the Trademark Property and reassign the same to Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Administrative Agent hereby releases its security interests in, and hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Administrative Agent, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto, including:

(i) each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and

(ii) all proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
