RELEASE OF SECURITY AGREEMENTS

This Release of Security Agreements, effective as of the 2<sup>nd</sup> of November, 2014, is made by Wells Fargo Capital Finance, LLC, successor-by-merger to Wells Fargo Capital Finance, Inc., formerly known as Wells Fargo Foothill, Inc. ("Wells Fargo"), as Collateral Agent ("Collateral Agent") for itself and the Lenders (as such term is used in the Security Agreements), in favor of PICIS, Inc., a Delaware corporation, as Grantor ("Grantor").

WHEREAS, Grantor and Collateral Agent entered into a Copyright and Security Agreement dated as of August 19, 2008; and a Pledge and Security Agreement dated as of August 8, 2007 (the "Security Agreements"), and

WHEREAS, Grantor and Collateral Agent entered into the Pledge Supplements (the "Pledge Supplements") to the Security Agreement dated as of August 8, 2007, which are referred to on Schedule 1 hereto, and

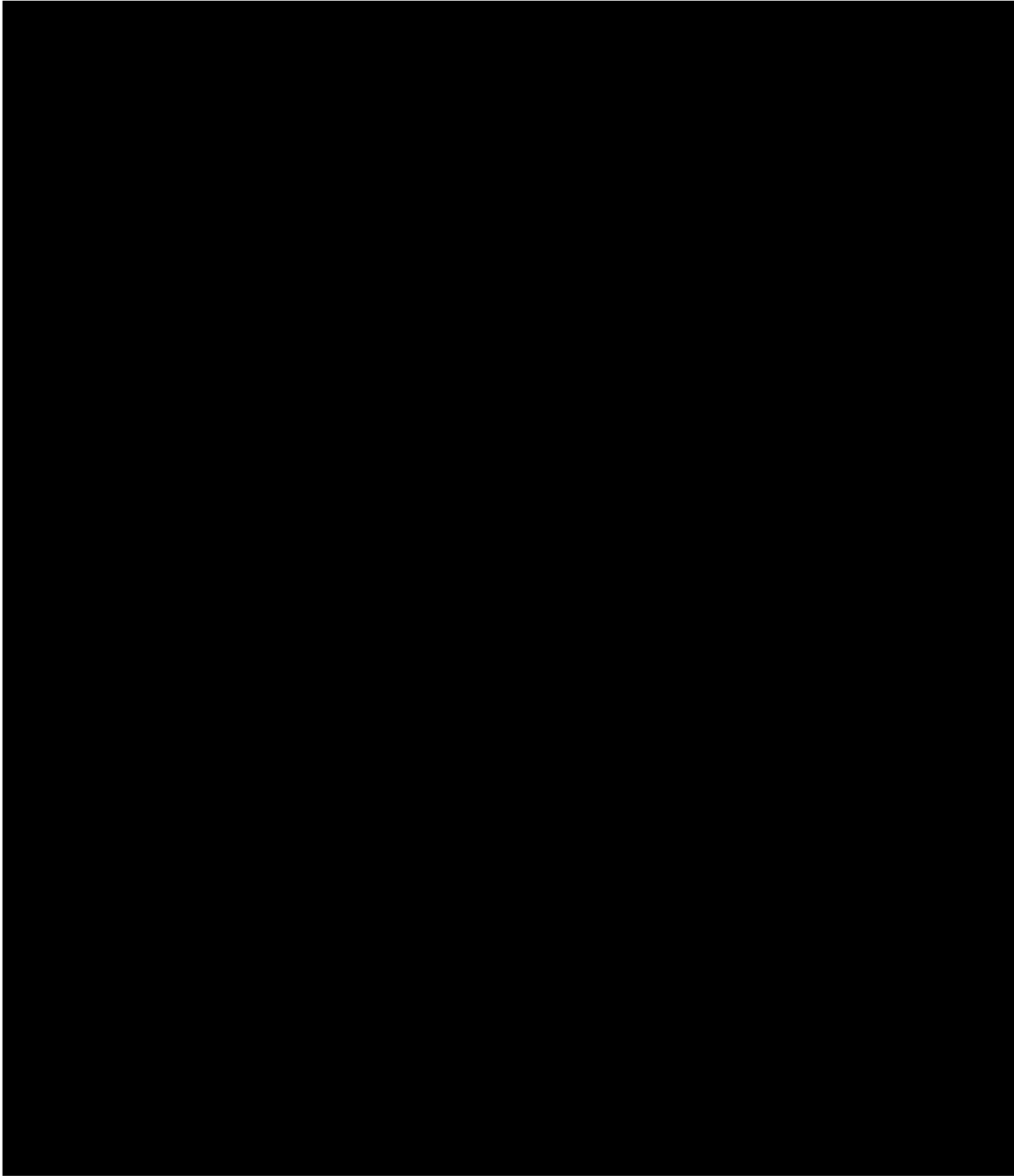
WHEREAS, under the Security Agreements, Grantor granted to Collateral Agent, on behalf of Collateral Agent and Lenders, a continuing first priority security interest in all of Grantor's right, title and interest in, to and under the Collateral (as such term is defined in the Security Agreements and referred to on Schedule 1 hereto).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Collateral Agent, on behalf of itself and the Lenders, does hereby (i) cancel and terminate the Security Agreements, (ii) declare the same null and void, of no further force and effect, (iii) cancel, terminate and release its entire interest in all of the Collateral, and (iv) release Grantor from all covenants, obligations, liabilities and warranties related to the Collateral under the Security Agreements and Credit Agreements (as such terms are defined in the Security Agreements).
