RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks, dated as of December 2, 2014 (the "Trademark Security Release"), is made by SOLAR CAPITAL, LTD., a Maryland corporation, in its capacity as administrative agent (in such capacity, the "Administrative Agent") in favor of DATA BASED SYSTEMS INTERNATIONAL, LLC, a Delaware limited liability company (the "Grantor"). Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement (as hereafter defined).

WHEREAS, the Administrative Agent and the Grantor entered into that certain Trademark Security Agreement, dated as of May 13, 2014 (as amended, restated, modified or supplemented from time to time, the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on May 22, 2014 at reel 5284, frame 0935 and on June 12, 2014 at reel 5301, frame 0462 the Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a Lien on and security interest in all of Grantor's right, title and interest in, to and under all of its Trademark Collateral, whether then existing or thereafter created or acquired, including, without limitation those Trademark Registrations and Trademark Applications set forth on the attached Schedule I;

WHEREAS, the Secured Obligations have been paid in full and the Commitments under the Loan Agreement have been cancelled; and

WHEREAS, the Grantor has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the Lien on and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release, reassign, transfer and reconvey its Lien on and security interest in the Released Collateral to Grantor, and (c) discharge any and all rights, title and interest it has in, and Lien on and the security interest granted to the Administrative Agent in the Released Collateral.
