**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this “Release”) is made as of December 2, 2014 (the “Effective Date”), by ROYAL BANK OF CANADA, (the “Administrative Agent”), acting in its capacity as Administrative Agent, in favor of TIERPOINT TEXAS, LLC, a Delaware limited liability company (formerly known as COLO4, LLC) (the “Grantor”).

WHEREAS, the Grantor and the Administrative Agent on behalf of the Secured Parties entered into that certain Borrower Security Agreement dated as of November 1, 2011, (as amended, restated, modified, or supplemented from time to time, the “Security Agreement”);

WHEREAS, pursuant to the terms of the Security Agreement Grantor executed that certain Trademark Security Agreement dated as of November 1, 2011 (as amended, restated, modified, or supplemented from time to time, the “Trademark Security Agreement”; capitalized terms used herein, but not defined shall have the meanings ascribed to them therein);

WHEREAS, Grantor granted to Administrative Agent on behalf of the Secured Parties a Lien and security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 9, 2011, at Reel 004657, Frame 0860; and

WHEREAS, Administrative Agent now desires to release its security interest in the Trademark Collateral, including without limitation, each trademark, Trademark Registration, Trademark Application and license referred to in Schedule 1 attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby covenants and agrees as follows:

1. Administrative Agent hereby terminates, releases, and discharges its Lien on and security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns, transfers and conveys to Grantor any and all right, title, and interest, now owned or hereinafter acquired, that Administrative Agent may have whether by assignment or otherwise, in and to the Trademark Collateral.

2. Administrative Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or as are required in order to fully and effectively carry out the purposes of this Release at the Grantor’s sole cost and expense.
