TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to Section 1106 of the Iowa Business Corporation Act ("IBCA"), the undersigned entities submit these Articles of Merger.

1. The names of the entities that are parties to the merger are: Telligen Health Management Solutions, Inc., an Iowa corporation ("THMS"), and Telligen, Inc., an Iowa corporation ("Telligen"). It is proposed that THMS will merge into Telligen and, following the merger, Telligen will be the surviving entity.

3. The Plan of Merger was duly approved by the board of directors of Telligen in the manner required by the IBCA and the Articles of Incorporation of Telligen. The Plan of Merger did not require the approval of the shareholders of Telligen.
4. The merger is to be effective on September 30, 2014 at 5:00PM Central Time.
