Pursuant to the provisions of Section 18-1090.5 of the Oklahoma General Corporation Act, *Rolling Hills Hospital, Inc., an Oklahoma corporation (the "Corporation")*, hereby certifies as follows relating to the conversion of the Corporation into Rolling Hills Hospital, LLC, an Oklahoma limited liability company (the "LLC"):

1. Rolling Hills Hospital, Inc. was formed under the Oklahoma General Corporation Act on September 15, 2006.
2. The jurisdiction of the Corporation immediately prior to the filing of this Certificate of Conversion is Oklahoma.
3. The name of the Corporation immediately prior to the filing of this Certificate of Conversion is Rolling Hills Hospital, Inc.
4. The name of the limited liability company as set forth in its Certificate of Formation is Rolling Hills Hospital, LLC.
5. The conversion of the Corporation into the LLC has been approved by the Corporation in the manner provided for by under Section 18.1090.5 of the Oklahoma General Corporation Act and its Certificate of Incorporation.
6. Upon the effective date of the conversion, all of the shares held by the sole shareholder of the Corporation shall, by virtue of the conversion and without any action on the part of such shareholder, be converted into 100% of the membership interests of the LLC. At the conclusion of the conversion, the ownership of the LLC shall be identical to the ownership of the Corporation immediately prior to the conversion.
7. As a result of the conversion, at the Effective Time, all shares of the Corporation shall cease to be outstanding, shall be canceled and retired and shall cease to exist, and the Company's sole shareholder shall thereafter cease to have any rights with respect to such shares, except the right to retain 100% of the membership interests of the LLC.
8. The Conversion shall be effective as of December 31, 2013 at 10:38 p.m. CST.
