ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Agreement"), dated as of June 27, 2013 (the "Effective Date"), is by and among S.A.C. DOMESTIC INVESTMENTS L.P. ("S.A.C."), in its capacity as existing collateral agent under that certain Security Agreement, dated as of November 8, 2006, as amended and restated as of February 22, 2013 (the "Security Agreement") and Z CAPITAL COMMERCIAL FINANCE, L.L.C. ("Z Capital"), in its capacity as succeeding collateral agent under the Security Agreement.

WITNESSETH:

WHEREAS, LTM Enterprises, Inc., a Nevada corporation ("Borrower"), Newways Parent S.à r.l., a Luxembourg société à responsabilité limitée ("Holdings"), certain other Guarantors from time to time party to the Security Agreement (Borrower, together with Holdings and such Guarantors, the "Pledgors," and each a "Pledgor") and S.A.C. are parties to the Security Agreement;

WHEREAS, pursuant to an Assignment and Acceptance Agreement, as of June 27, 2013, S.A.C. has assigned all of its rights, remedies, title and interests as Collateral Agent under the Security Agreement, including, without limitation, a lien on and security interest in and to the Pledged Collateral (the "Security Interest") to Z Capital, and Z Capital is now the "Collateral Agent" under the Security Agreement;

WHEREAS, the Security Interest assigned to Z Capital includes, without limitation, a lien on and security interest in and to the trademark registrations and applications set forth on Schedule 1 (the "Trademarks"), the patents set forth on Schedule 2 (the "Patents") and the copyright registrations set forth on Schedule 3 (the "Copyrights");

WHEREAS, the Security Interest, as previously held by S.A.C., has been recorded (i) in the United States Patent and Trademark Office with respect to the Trademarks pursuant to the Trademark Security Agreements identified on Exhibit A-1 and with respect to the Patents pursuant to the Patent Security Agreements identified on Exhibit A-2 and (ii) in the United States Copyright Office with respect to the Copyrights pursuant to the Copyright Security Agreements identified on Exhibit A-3;

NOW, THEREFORE, the parties hereto hereby agree as follows:

1 Definitions. Unless otherwise defined herein, terms used herein which are defined in the Security Agreement shall have the meanings given to such terms in the Security Agreement.

2 Assignment of Security Interest in Intellectual Property.

2.1 Assigned Security Interest. Effective as of the Effective Date, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged,

S.A.C. hereby assigns to Z Capital all of its rights, powers, privileges and duties under, and Z Capital hereby succeeds to all of S.A.C.'s rights, powers, privileges and duties in and to any and all security interests and liens of any type created under or pursuant to those instruments and documents (each as amended and in effect from time to time) described on the attached Exhibits A-1, A-2 and A-3, together with any and all other documents, guarantees and security agreements executed at any time in connection therewith for the benefit of the Collateral Agent, and including, without limitation, all of S.A.C.'s security interests and liens on the Trademarks, Patents and Copyrights (collectively, the "Assigned Security Interest"), in each case without representation, warranty or recourse.

2.2 Authorization. Effective as of the Effective Date, and solely with respect to such instances where S.A.C.'s authorization therefor is required, S.A.C. hereby authorizes Z Capital to file, register and/or record this Agreement with the United States Patent and Trademark Office, the United States Copyright Office and any other similar office for which filing, registration or recordation is reasonably necessary to effect and/or evidence the assignment of the Assigned Security Interest from S.A.C. to Z Capital.

2.3 Further Assurances. S.A.C. shall use commercially reasonable efforts to execute and deliver, from time to time, upon the reasonable written request of Z Capital, and at the sole expense of the Pledgors, any and all such further instruments and documents and take such further reasonable action as Z Capital may reasonably deem necessary to obtain the full benefits of the Assigned Security Interest.

3 Effectiveness of Agreement; Miscellaneous.

3.1 Headings. Section, subsection and other headings used in this Agreement are for convenience only and shall not affect the construction of this Agreement.

3.2 Severability. Any provision of this Agreement which is prohibited or unenforceable in any jurisdiction shall not invalidate the remaining provisions hereof, and any such prohibition or unenforceability in any jurisdiction shall not invalidate or render unenforceable such provision in any other jurisdiction.

3.3 Binding Effect. This Agreement shall be binding upon and inure to the benefit of each of the parties hereto and their respective successors and assigns.

3.4 GOVERNING LAW. THE PROVISIONS OF THIS AGREEMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAW OF THE STATE OF NEW YORK WITHOUT GIVING EFFECT TO ANY CHOICE OF LAW PRINCIPLES THAT WOULD APPLY THE LAWS OF ANOTHER JURISDICTION.

3.5 Counterparts; Effectiveness. This Agreement may be executed in separate counterparts, each of which shall be an original and all of which taken together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page of this Agreement by telecopy or electronic mail shall be effective as delivery of a manually executed counterpart of this Agreement.






