This Assignment may be executed in one or two counterparts, each of which when so executed and delivered shall be deemed an original, and both of which together shall constitute one and the same instrument.

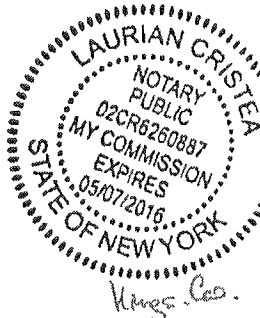
