This **NOTICE OF SUBSTITUTION OF SECURED PARTY IN TRADEMARKS** (this "Notice") is effective as of November 25, 2014 (the "Effective Date"), by and among (i) **CURTCO ROBB MEDIA, LLC**, a Delaware limited liability company (the "Grantor"), (ii) **ROBB MEDIA INTERMEDIATE HOLDINGS, LLC**, the current Agent under the Existing Credit Agreement (in such capacity, the "Current Agent"), and (iii) **ROBB MEDIA INTERMEDIATE HOLDINGS, LLC**, as the lender and successor secured party under the Credit Agreement (in such capacity, together with its successors and assigns in such capacity, the "Successor Secured Party"). Capitalized terms used herein and not defined herein shall have the meanings assigned to such terms in the Credit Agreement.

WITNESSETH

WHEREAS, reference is made to that certain Second Amended and Restated Credit Agreement, dated as of November 25, 2014, by and among the Grantor, in its capacity as borrower ("Borrower"), the other Credit Parties from time to time party thereto and the Successor Secured Party (as amended prior to the date hereof, the "Credit Agreement");

WHEREAS, the Current Agent, the Successor Secured Party and the other parties to the Credit Agreement entered into that certain Secured Party Transition Agreement (the "Agreement"), dated as of November 25, 2014, which acknowledged the elimination of the role of agent as provided in the Credit Agreement and vested the Successor Secured Party with the rights, powers, privileges and duties of the Current Agent under the Existing Credit Agreement and the other Loan Documents;

WHEREAS, pursuant to the Agreement, the Current Agent assigned to the Successor Secured Party all the rights and duties of the Current Agent under the Loan Documents (including without limitation, the Amended and Restated Security Agreement, dated as of May 3, 2012 by Grantor in favor of Current Agent, as successor agent to Robb Media Investors, LLC, as successor agent to General Electric Capital Corporation, as the same may be amended, restated, amended and restated, supplemented or modified from time to time, the "Security Agreement" and the Trademark Security Agreement, dated as of May 3, 2012 by Grantor in favor of Current Agent, as successor agent to Robb Media Investors, LLC, as successor agent to General Electric Capital Corporation, as the same may be amended, restated, amended and restated, supplemented or modified from time to time); and

WHEREAS, the Current Agent is executing this Notice for the purpose of giving notice of the transfer of the Current Agent's right, title, and interest in the Collateral (as defined in the Security Agreement) to the Successor Secured Party pursuant to the Agreement;
