**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of December 9, 2014, is made by FIFTH STREET FINANCE CORP., a Delaware corporation, as Administrative Agent for itself and for certain other Lenders (as defined in the Credit Agreement referred to below) (together with its successors and assigns in such capacity, "**Administrative Agent**"). Capitalized terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement.

**WHEREAS**, DISA GLOBAL SOLUTIONS, INC., a Delaware corporation formerly known as DRUGTEST, INC. and successor by merger to DRUGTEST MERGER SUB, INC. (the "**Borrower**"), Administrative Agent and the lenders from time to time party thereto are each a party to that certain Credit Agreement, dated as of December 30, 2010, as amended and restated by that certain Amended and Restated Credit Agreement dated as of June 27, 2013, and as further amended by that certain First Amendment and Waiver to Amended and Restated Credit Agreement dated as of December 20, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**");

**WHEREAS**, in connection with the Credit Agreement, Borrower and Administrative Agent entered into that certain Security Agreement, dated as of December 30, 2010, as consented to, reaffirmed and ratified by that certain Consent, Reaffirmation and Ratification of Security Agreement dated June 27, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreement**");

**WHEREAS**, in connection with the Security Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Intellectual Property Collateral Assignment Agreements**"), Borrower and Guarantors (collectively, "**Assignors**") granted Administrative Agent security interests in certain intellectual property owned by the Assignors, including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and

**WHEREAS**, the Intellectual Property Collateral Assignment Agreements were recorded in the U.S. Patent and Trademark Office, as applicable, on the dates and on the reels and frames set forth on Annex I hereto;

**NOW, THEREFORE**, the Administrative Agent hereby releases, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreement, the Intellectual Property Collateral Assignment Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in the Intellectual Property Collateral to the Assignors.

The Administrative Agent agrees, at the expense of the Assignors, to cooperate with the Assignors and to provide the Assignors with the information and additional authorization reasonably required to effect the release of the Administrative Agent's security interests in the Intellectual Property Collateral.
