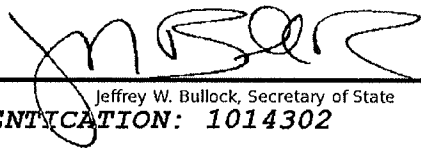

**CERTIFICATE OF CONVERSION
OF
ACADIA - YFCS HOLDINGS, INC.
(a Delaware corporation)
TO
ACADIA - YFCS HOLDINGS, LLC
(a Delaware limited liability company)**

Pursuant to the provisions of Section 18-214 of the Delaware Limited Liability Company Act, Acadia - YFCS Holdings, Inc., a Delaware corporation (the "Corporation"), hereby certifies as follows relating to the conversion of the Corporation into Acadia - YFCS Holdings, LLC, a Delaware limited liability company (the "LLC"):

1. Acadia - YFCS Holdings, Inc. was formed under the Delaware General Corporation Law on February 1, 2011.
2. The jurisdiction immediately prior to the filing of the Certificate of Conversion is Delaware.
3. The name of the Corporation immediately prior to the filing of this Certificate of Conversion is Acadia - YFCS Holdings, Inc.
4. The name of the limited liability company as set forth in its Certificate of Formation is Acadia - YFCS Holdings, LLC.
5. The conversion of the Corporation into the LLC has been approved by the Corporation in the manner provided for by under Section 18-214 of the Delaware Limited Liability Company Act.
6. Upon the filing of the Certificate of Conversion to effect the conversion, all of the shares held by the stockholder of the Corporation shall, by virtue of the conversion and without any action on the part of such stockholder, be converted into 100% of the membership interests of the LLC. At the conclusion of the conversion, the ownership of the LLC shall be identical to the ownership of the Corporation immediately prior to the conversion.
7. As a result of the conversion and without any action on the part of the Corporation's sole stockholder, at the Effective Time, all shares of the Corporation shall cease to be outstanding, shall be canceled and retired and shall cease to exist, and the Corporation's sole stockholder shall thereafter cease to have any rights with respect to such shares, except the right to retain 100% of the membership interests of the LLC.
8. Upon the effective date of the conversion, a written operating agreement has been entered into among the sole member of the LLC.
9. The conversion shall be effective as of December 31, 2013 at 11:58 p.m. EST.

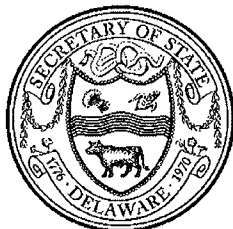

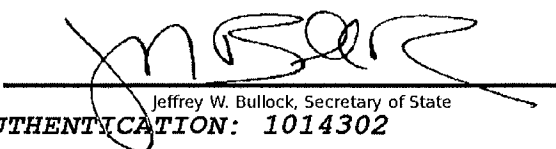
