TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "Termination") is granted as of December 11, 2014, by **COMERICA BANK** ("Bank"), in favor of **CORVENTIS, INC.**, a Delaware corporation (the "Grantor").

WHEREAS, the Bank made certain advances of money and extended certain financial accommodations to the Grantor in the amounts and manner set forth in that certain Loan and Security Agreement dated as of December 20, 2012 (as has been amended, modified, or supplemented from time to time, the "Loan Agreement");

WHEREAS, as a condition of the Bank making the advances to the Grantor as set forth in the Loan Agreement, the Grantor granted the Bank a security interest in certain Collateral (as defined below) by way of an Intellectual Property Security Agreement dated as of December 20, 2012;

WHEREAS, the Intellectual Property Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office ("PTO") on January 10, 2013, at Reel 029608, Frame 0809, against certain patents identified on Exhibit B hereto;

WHEREAS, the Intellectual Property Security Agreement was recorded in the Trademark Division of the PTO on January 10, 2013, at Reel 4940, Frame 0506, against certain trademarks identified on Exhibit C hereto;

WHEREAS, the Grantor has satisfied all of the obligations under the Loan Agreement and has requested that the Bank terminate and release its security interests in and liens on the Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby agrees as follows:

(1) Definitions.

(a) All capitalized terms used herein shall have the meaning ascribed to them in the Loan Agreement, unless otherwise defined in this Termination.

(b) The term "Collateral", as used herein, shall mean whether presently existing or hereafter created, written, produced or acquired, including, but not limited to: Grantor's Intellectual Property Collateral (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A, B and C hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof.

(2) Release of Security Interest in Collateral. The Bank hereby terminates, releases, and discharges its security interest in the Collateral.

(3) Reassignment. The Bank hereby reassigns, grants, and conveys to the Grantor, without any representation, recourse or undertaking by the Bank, all of the Bank's right, title, and interest in and to the Collateral.
