RELEASE OF SECURITY INTEREST IN TRADEMARKS

Secured Party agrees to cooperate with the Grantor and to provide the Grantor with the information and additional authorization reasonably required or desirable to effect the release of the Secured Party's security interest in the Released Trademarks and the termination of the Trademark Filings.


