**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of December 12, 2014, is made by HERCULES TECHNOLOGY GROWTH CAPITAL, INC., in its capacity as agent for the Lenders (the "Agent"), pursuant to the Loan and Security Agreement, dated as of October 31, 2014 (as amended, restated, or otherwise modified from time to time, the "Loan Agreement"). Capitalized terms not otherwise defined herein have the meaning assigned to them in the Loan Agreement.

**WITNESSETH**

WHEREAS, IronPlanet, Inc., a Delaware corporation, IronPlanet Motors, LLC, a Delaware limited liability company, Asset Appraisal Services, Inc., a Delaware corporation, and GovPlanet, LLC, a Delaware limited liability company (individually and collectively, the "Grantor") are parties to the Loan Agreement;

WHEREAS, pursuant to the Loan Agreement, the Grantor executed the Intellectual Property Security Agreement dated October 31, 2014 and recorded with the U.S. Patent and Trademark Office on November 4, 2014 at Reel/Frame Nos. 34151/0030, 5393/0744, and 5393/0758 (the "Intellectual Property Security Agreement"), pursuant to which the Grantor granted and pledged to the Agent for its benefit and the benefit of the Lenders a security interest in all of its right, title and interest in, to and under the Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:


The Agent hereby TERMINATES, without recourse, representation or warranty the Intellectual Property Security Agreement, and RELEASES, without recourse, representation or warranty its security interest in all of the Intellectual Property Collateral, including the patents, trademark registrations, and trademark applications set forth in Schedule I, attached hereto and incorporated herein by reference.

The Agent agrees to provide the Grantor with any additional authorization reasonably necessary to effect the release of the Agent's security interest in the Intellectual Property Collateral.
