## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is given as of February 28, 2013 to EBI, LLC, an Indiana limited liability company (as successor to EBI, L.P.) ("EBI"), by BANK OF AMERICA, N.A., as Administrative Agent ("Agent").

WHEREAS, pursuant to that certain (i) Credit Agreement (Cash Flow) dated as of September 25, 2007, as amended and restated as of August 2, 2012, by and among Biomet, Inc. (the "Company"), EBI, LVB Acquisition, Inc., as Holdings ("Holdings"), certain other subsidiaries of the Company identified therein and Agent, and the other lenders from time to time party thereto (as amended, supplemented or otherwise modified from time to time in accordance with its terms, the "Cash Flow Credit Agreement"), (ii) Pledge and Security Agreement (Cash Flow) dated as of September 25, 2007, by and among the Company, as the Borrower, Holdings, EBI, the several other subsidiary borrowers party thereto, and Agent (as amended, supplemented or otherwise modified from time to time in accordance with its terms, the "Cash Flow Security Agreement"), (iii) Credit Agreement dated as of November 14, 2012, among the Company, Biomet Global Supply Chain Center B.V., EBI, the several other subsidiary borrowers party thereto, Holdings, Agent, as Administrative Agent, Swing Line Lender and L/C Issuer, and each lender from time to time party thereto (as amended, supplemented or otherwise modified from time to time in accordance with its terms, the "ABL Credit Agreement") and (iv) U.S. Pledge and Security Agreement dated as of November 14, 2012 among Holdings, the Company, EBI, certain other domestic subsidiaries of the Company and Agent (as amended, supplemented or otherwise modified from time to time in accordance with its terms, the "ABL Security Agreement"), Company, Holdings, EBI, certain other subsidiary borrowers party thereto, and Agent entered into that certain Trademark Security Agreement, dated as of September 25, 2007 (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, Company, EBI and certain other subsidiary grantors granted to Agent a security interest in all right, title, and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks identified on Exhibit A to this Release (the "Released Trademarks");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 10, 2007, at Reel 3674, Frame 0700, and on November 12, 2009, at Reel 4095, Frame 0124; and


WHEREAS, Agent desires to release any and all security interests in and liens it has against the Released Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged: (i) Agent hereby terminates, cancels, discharges and releases its lien on and security interest in the Released Trademarks; (ii) Agent assigns any and all interest it may have in the Released Trademarks to EBI; and (iii) Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as, at EBI or Breg's sole cost and expense, may be reasonably requested by EBI, Breg, Inc. ("Breg") or their respective representatives in order to more fully and effectively carry out the purposes of this Release. This Release is limited to and shall relate solely to the Released Trademarks. Nothing herein shall be construed as a release of any other collateral under the ABL Security Agreement or the Trademark Security Agreement.
