**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”) is given as of this 10 day of December 2014 by Bank of America, N.A. as successor to LaSalle Business Credit, LLC (“Assignor”) in favor of Lincoln Paper and Tissue, LLC, a Delaware limited liability company (“Assignee”).

WHEREAS, pursuant to a Security Agreement executed as of August 24, 2005 (the “Security Agreement”), Assignee granted, assigned and conveyed to Assignor a security interest in certain Trademarks (which, for clarity, are set forth on Schedule A) and the goodwill of the business symbolized by the Trademarks (collectively, the “Trademark Collateral”) and the Security Agreement was recorded with the U.S. Patent & Trademark Office (“PTO”) on May 20, 2009 at Reel/Frame 3990/0207, et seq;

WHEREAS, Assignee’s debt has been paid in full and all security interests in the Trademark Collateral have been terminated; and

WHEREAS, the parties desire to confirm the release of all security interests which had been granted in favor of Assignor in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

Assignor hereby terminates, releases and discharges fully its security interest in the Trademark Collateral.

Assignor hereby authorizes Assignee or Assignee’s authorized representative to (i) record this Release with the PTO, (ii) file UCC Financing Statement Amendments with the applicable filing office in order to memorialize the release of any security interest of Assignor in the Trademark Collateral, and/or (iii) otherwise file this Release.


