**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of December 12, 2014, by AMEGY BANK NATIONAL ASSOCIATION (together with its successors and assigns, "Secured Party").

WHEREAS, reference is made to a certain Intellectual Property Security Agreement dated November 17, 2006, by and between NOUVEAU EYEWEAR, INC., a Delaware corporation ("Grantor"), and Secured Party; all capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement; and

Further, Secured Party understands and agrees that this Release may be recorded by or for Grantor with the United States Patent and Trademark Office and any other similar office or agency throughout the world. Secured Party also agrees to execute any other documents and take any further action reasonably necessary in any jurisdiction that Grantor may reasonably require to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflicts of law principles.
