DECLARATION OF ROD COLEMAN

21 ROD COLEMAN declares under penalty of perjury that the following is true and correct:

- 22 1. I am an adult, and I am competent to make this declaration of my own personal
23 knowledge.
- 24 2. I am the former President and Chief Executive Officer of MarketFare Foods, Inc.
- 25 3. MarketFare Foods, Inc. was an Arizona corporation with its principal place of
26 business in Phoenix, Arizona.
4. MarketFare Foods, Inc. maintained its corporate offices in Phoenix, Arizona and
managed production facilities in Salt Lake City, Utah and Fredericksburg, Virginia.
5. Between May, 1999 and approximately April 18, 2012, MarketFare Foods, Inc.
engaged in the business of food manufacturing and distribution.
6. MarketFare Foods, Inc.'s business entailed manufacturing food products for sale at
convenience stores, grocery stores, drug stores, and vending machines throughout the country.

1 7. In or about June, 2009, MarketFare Foods, Inc. took initial steps to develop a
2 refrigerated breakfast sandwich product at its Fredericksburg, Virginia facility.

3 8. In or about May, 2010, MarketFare Foods, Inc. made a determination to brand its new
4 breakfast sandwich as THE GRIDDLER.

5 9. The development of THE GRIDDLER product was transitioned to MarketFare
6 Foods, Inc.'s Salt Lake City, Utah facility, and development was thereafter directed at a frozen
7 product for national distribution through convenience stores and grocery stores.

8 10. On June 17, 2010, MarketFare Foods, Inc. caused an application for registration for
9 the trademark THE GRIDDLER to be filed with the United States Patent and Trademark Office for
10 breakfast sandwiches in International Class 30 pursuant to Section 1(b) of the Lanham Act (App.
11 Serial No. 85065325).

12 11. Presentations of THE GRIDDLER product and THE GRIDDLER mark were made to
13 prospective customers of MarketFare Foods, Inc. as early as June, 2010, and the breakfast sandwich
14 product was put into production in November, 2010.

15 12. Samples of THE GRIDDLER product bearing THE GRIDDLER mark were
16 presented to select grocery stores and convenience stores in California, Kansas, Ohio, and Texas, and
17 at a trade show in Illinois, in 2010.

18 13. THE GRIDDLER frozen product line has included maple hot cake sandwiches,
19 sausage sandwiches, sausage and cheese sandwiches, and sausage, egg, and cheese sandwiches.

20 14. THE GRIDDLER product was first sold to the public at a convenience store in Salt
21 Lake City, Utah in November of 2010.

22 15. Attached hereto as Exhibit "1" are true and correct copies of labels affixed to THE
23 GRIDDLER products sold in commerce.

24 16. Due in principal part to its dispute with Sara Lee Foods, LLC, MarketFare Foods, Inc.
25 caused THE GRIDDLER product to temporarily be sold under a different brand name "Marketfare"
26 in Alabama, Arizona, California, Colorado, Georgia, Illinois, Kentucky, Florida, Minnesota,

1 Mississippi, New York, North Carolina, Pennsylvania, Texas, Virginia, and Washington to avoid
2 potential confusion with Sara Lee Foods, LLC's branded breakfast sandwich products during the
3 pendency of this action.


4 17. On or about April 18, 2012, the operations of MarketFare Foods, Inc. were acquired
5 by Greencore USA, Inc. through a merger.

6 18. On or about April 18, 2012, all right, title, and interest in THE GRIDDLER mark,
7 including United States Patent and Trademark Office App. Serial No. 85065325, were acquired by
8 Greencore USA, Inc. through a merger.

9 19. Between May, 2010 and April 18, 2012, MarketFare Foods, Inc. maintained a
10 genuine intent to use the mark THE GRIDDLER in commerce for breakfast sandwiches.

11 FURTHER DECLARANT SAYETH NOT.

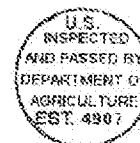


