**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of December ~~14~~, 2014, is made by **TEXAS CAPITAL BANK, N.A.** (the "Lender"), under the Trademark Security Agreement referred to below.

WHEREAS, Future Food, Ltd., a Texas limited partnership (the "Company") is a party to that Agreement (Trademarks), dated as of February 22, 2001 (the "**Trademark Security Agreement**") made by the Company in favor of the Lender, pursuant to which the Company granted to the Lender a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement), including the Trademarks listed on Annex I attached hereto; and

NOW THEREFORE, the Lender hereby releases, without representation, recourse or warranty whatsoever, its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and the Lender hereby reassigns any and all such right, title and interest that the Lender may have in the Trademark Collateral to the Company.

The Lender agrees, at the Company's expense, to cooperate with the Company to provide the Company with any additional information or authorization reasonably required or desirable to effect the release of the Lender's security interest in the Trademark Collateral.
