## **RELEASE OF SECURITY INTEREST**

### **TRADEMARKS**

This RELEASE OF SECURITY INTEREST, dated as of December 15, 2014, is executed by Ares Capital Corporation, a Maryland corporation ("Lender"), in favor of RainStor, Inc., a Delaware corporation ("Grantor").

A. Pursuant to that certain Loan and Security Agreement, dated as of March 28, 2013 (as amended, supplemented or otherwise modified from time to time, the "Loan Agreement"), between Grantor and Lender, Lender agreed to extend loans and other financial accommodations to Grantor upon the terms and subject to the conditions set forth therein.

B. Lender hereby releases, waives, resigns and disclaims any and all security interest in any of the Trademarks, and thereby extinguishes the Security Agreement in its entirety.
