RELEASE OF SECURITY INTEREST IN TRADEMARK, dated as of December 15, 2014 (this "Release"), by **JPMORGAN CHASE BANK, N.A.**, a national association with an address at 10 S. Dearborn, 7th Floor, Chicago, IL 60603 ("JPM"), as Collateral Agent, in favor of **INPHYNET CONTRACTING SERVICES, INC.**, a Florida corporation with an address at 14050 NW 14th St., Suite 190, Fort Lauderdale, FL 33323 (the "Grantor"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreement, as applicable, referred to below.

A. Reference is made to (i) the Amended and Restated Credit Agreement, dated as of October 2, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Team Health, Inc., a Tennessee corporation (the "Borrower"), Team Health Holdings, Inc. a Delaware corporation ("Holdings"), the Lenders from time to time party thereto and JPM, as Administrative Agent, Swine Line Lender and L/C Issuer (ii) the Intellectual Property Security Agreement, dated as of June 29, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the Borrower, Holdings, the Subsidiaries of Holdings identified therein and JPM, as Collateral Agent, (iii) the Trademark Security Agreement, dated as of June 29, 2011, among the Borrower, the Subsidiaries of the Borrower identified therein and JPM, as Collateral Agent (the "Trademark Security Agreement").

B. Pursuant to the Security Agreement, the Grantor granted to JPM, for the benefit of the Secured Parties, a security interest in all right, title and interest of the Grantor in the Trademark set forth on Schedule I hereto (the "Trademark Collateral"), and such security interest was recorded with the United States Patent & Trademark Office on July 19, 2011 at Reel/Frame 4585/0656.

C. JPM now wishes to terminate and release the entirety of its security interest in the Trademark Collateral;

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, JPM does hereby release, relinquish and discharge any and all security interests it has in the Trademark Collateral listed on Schedule I. This Release is made without representation or warranty by, or recourse to, JPM or any other Secured Party. This Release does not release, relinquish, discharge or terminate JPM's security interest in any Intellectual Property or any other asset of the Grantor other than the Trademark Collateral set forth in Schedule I hereto.




