

Pursuant to Title 6, Section 18-209 of the Limited Liability Company Act, the undersigned limited liability company hereby certifies as follows:

FIRST: The name and jurisdiction of organization of each of the limited liability companies that are to merge are as follows:

CP Subsidiary, LLC	Delaware

SECOND: An agreement of merger has been approved, adopted, certified, executed, and acknowledged by the constituent limited liability companies.
